## JUSTIFICATIVAS

Considerando que o município de Sorriso está em franca expansão, com mais de 100 (cem) bairros e população média acima de 92.000 (noventa e dois mil) habitantes, a qual atualmente não é completamente atendida com os serviços de entrega de correspondências pelos Correios;

Considerando que apenas 30% da cidade de Sorriso recebe cobertura dos referidos serviços e que nesse referido bairro tem várias empresas instaladas, que pela questão de localidade as encomendas fossem entregues pelo correio do Rota do Sol, por carteiros, seria mais adequado;

Considerando a grande quantidade de empresas (116 empresas ativas) instaladas no referido bairro, os quais, para terem acesso aos serviços dos Correios, necessitam deslocarem-se para a Agência Central ou Park Shopping Sorriso, que ficam demasiadamente distante;

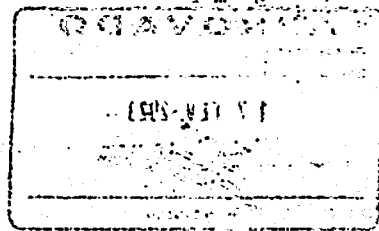
Considerando que a falta dos serviços postais à grande parcela da população, inibe o crescimento econômico, ocasiona problemas sociais, uma vez que obsta o inter-relacionamento pessoal e empresarial, ocasionando danos financeiros;
